The Transgender Law Center (TLC) is a civil rights organization advocating for transgender communities. Every day we connect transgender people and their families to technically sound and culturally competent legal services, increase acceptance and enforcement of laws and policies that support California's transgender communities, and work to change laws and systems that fail to incorporate the needs and experiences of transgender people.

With offices in San Francisco and Los Angeles, TLC utilizes direct legal services, public policy advocacy, and educational opportunities to advance the rights and safety of diverse transgender communities. TLC uses the term "transgender" to represent all of the innumerable genders and forms of gender expression that fall within and outside of stereotypical gender norms. TLC also understands, acknowledges, and resists non-gender based oppressions which limit people's ability to live in peace.

Brazilian Torture Survivor Secures Right to Remain in U.S.

Born in Brazil, Leah (not her real name) transitioned to live full time as a woman in the 1990s. In her home country, she was beaten and tortured by police officers and incarcerated in a police-run house of prostitution in Rio de Janeiro. Leah finally

escaped and fled to San Francisco. Beginning in January 2008, Leah was held in custody by U.S. Immigration and Customs Enforcement (ICE) in a local men's jail.

TLC represented Leah at a "reasonable fear" interview and asked the Lawyers' Committee for Civil Rights Asylum Program for help in securing pro bono legal counsel. Kyra Sanin and Dan Komarek of Kirkland & Ellis LLP served as lead counsel with Beth Feinberg of Van Der Hout Brigagliano & Nightingale, LLP providing expert assistance. On April 8, 2008, Sanin, Kimarek and TLC presented Leah's case. She was granted withholding of removal and relief under the Convention Against Torture.



Statewide Leadership Council Takes on Sacramento

TLC has established a statewide
Leadership Council to engage in advocacy
at the state level, particularly regarding
transgender workforce development
and health care access. The Council
convened in Sacramento in December
2008 for trainings on policy advocacy,
workforce development systems, and
budget advocacy, and met with Herb
Schultz, Senior Advisor to Governor
Schwarzenegger, about transgender

Empowering Youth to Implement State Non-Discrimination Laws

TLC is collaborating with Gay-Straight Alliance Network (GSA Network) on a multi-year youth advocacy effort to ensure implementation of the gender identity components of The California **Student Safety and Violence Prevention Act of** 2000 and the Student Civil Rights Act of 2007. TLC helped to lead trainings for a core group of youth leaders from across the state in May and October, and co-sponsored GSA Network's annual Queer Youth Advocacy Day in Sacramento. The trainings empowered youth to understand and address gender identity issues in their individual schools and to participate in multiple strategies for shifting state policies. As part of this collaboration, TLC staff and GSA Network youth presented to the California School Boards Association (CSBA) in December, and advocated with officials from the California Department of Education.

Other Accomplishments

- TLC organized workshops reaching over 1,300 community members, legal professionals, and social service providers.
- TLC provided individualized legal services to over 1,200 community members and/or their families.
- TLC conducted the 2008 CA Transgender Economic Health Survey, a groundbreaking study on the economic well-being of transgender communities in California.

Senate Public Safety Committee Hears Concerns Facing LGBT People in California's Prisons

TLC, along with partner organizations Transgender Gender Variant Intersex Justice Project, National Center for Lesbian Rights, Equality California and Just Detention International, organized an official California Senate Committee on Public Safety meeting to examine issues facing LGBT people in California's prison system. Chaired by Senator Gloria Romero, and attended by Assembly Member Tom Ammiano, the December meeting focused on the LGBT population in prison and the unique issues LGBT inmates face while incarcerated, including harassment and abuse, prisoner classification systems, unequal access to healthcare, and difficulties faced when re-entering into society.

Speakers at the meeting included our own Masen Davis, Miss Major and Alexander Lee of TGIJP, Bamby Salcedo of Childrens Hospital of Los Angeles, Professor Valerie Jenness of UC Irvine. Dr. Lori Kohler of UCSF, and Linda McFarlane of JDI. The witnesses discussed problems with the current classification system, which harms LGBT people by putting them at increased risk of violence and harassment, and suggested policy changes that would improve safety without costing the corrections system additional money. One such policy recommendation spurred Assembly Member Ammiano to author a bill, AB 382, which would require the Department of Corrections and Rehabilitation to take gender identity and sexual orientation into account when making decisions about where to house prisoners. Following the meeting, the San Francisco Bay Guardian published an important article drawing attention to the human rights crisis faced by LGBT people in California Prisons.

- The annual Transgender Leadership Summit, held in Berkeley in 2008, drew nearly 300 participants for 3 days of training and discussion.
- TLC joined other public interest legal organizations and bar associations in submitting an amicus brief in Strauss v Horton, the case challenging the validity of Proposition 8.
- TLC launched its first strategic planning effort, and invested in mission-critical infastructure.

Building a Statewide Movement for Transgender Health

ILC has launched several programs to increase access to quality healthcare for transgender people. We organized transgender health law workshops to teach community members about their rights and ways to negotiate with their own providers for better care. We encouraged community organizing with local clinics and other providers for expanded or improved services – and in the last year clinics in Alameda, Los Angeles, and Santa Clara Counties expanded their trans-specific services, while community members in San Bernardino began providing cultural competency training to local mental health providers. Increasing numbers of community members who had nowhere to go for health care, or who were relying on unregulated "street" hormones, can now receive full health services and hormone support at community clinics. To further improve access to primary and transitionrelated care, we launched Project H.E.A.L.T.H (Harnessing Education, Advocacy and Leadership for Transgender Health) in partnership with Lyon-Martin Health Services (LMHS), a community clinic with a history of providing transinclusive services. LMHS doctors can now provide peer-to-peer training and guidance to clinic staff in various regions of the state while TLC staff and volunteers mobilize providers and community members to advocate for transgender-specific care and insurance coverage.

We also organized a pre-conference institute on insurance discrimination at the Task Force's Creating Change conference, and provided conference scholarships for two community organizers from L.A.'s Community Clinics Campaign (a TLC/ FTM Alliance of LA partnership) to present a workshop on their efforts. Since funding often limits clinics' ability to expand

services, we also began offering training on budget advocacy to local community members.

In 2008, we provided health-related individualized legal assistance to hundreds of community members. We won a case in which Medi-Cal had initially denied the costs of replacing a defective breast implant that burst, even though the replacement implant itself was covered by warranty. We also secured an independent medical review on behalf of a client in a state mental facility who was abruptly taken off his hormones, with serious adverse results. The client's hormone therapy was reinstated, and we are working with the state Department of Mental Health to develop policies for the care of transgender patients in state mental facilities. Because we continue to see numerous cases in which patients are denied appropriate coverage for care, despite California's Insurance Gender Non-Discrimination Act, we collaborated with the National Center for Lesbian Rights to research the best fact pattern for future litigation. We also provided training to more than 100 employers about negotiating transgender-inclusive health insurance policies, and are supporting employees in advocating with their employers for improved coverage

TLC also helped launch California's LGBT Health and Human Services Network, which advocates for increased support and funding for LGBT health programs throughout the state. Executive Director Masen Davis serves on the Network's Executive Committee, and represented the coalition on a 10-member delegation of U.S. LGBT health advocates who met with members of the Obama transition team to identify LGBT health reform priorities in December.


